0. SUMMARY OVERVIEW, MARKET UPDATE

RECENT DEVELOPMENTS – Marketing year 2019/20

1. As expected from a moderate crop, prices during the ongoing campaign are moving within ranges significantly above the average price for the historical reference 5 year period.
2. When comparing to the difficult preceding marketing year (excess of supply in some Member States, especially in Poland) a very important price recovery was observed. Marketing year 2019/20 started the 1st of August. According to Wapa/Prognosfruit the new crop is relatively small (-20% on preceding year and -11% below 5 year reference average). In this context average prices for the new crop are expected to go far beyond the 5 year average).
3. The remaining stocks from the preceding crop were rather high but there was small impact from these stocks since represent just 4,6% of the average crop. EU apple stocks on 1.12.2019 were at the lowest of the last 7 years.
4. The EU price average is significantly above the reference average. At Member State level, however, situations diverge to some extent:
 - prices in PL had a major positive change from previous very low levels;
 - FR prices are above reference average but lower than the preceding campaign (this is an exception to the rule, France increased production during this period);
 - DE prices were slightly above average;
 - IT prices recovered gradually from a difficult end to the previous marketing year.
5. During the ongoing campaign there are two important factors to look at that are fundamental for EU prices and farm incomes:
 - a) internal EU demand (that could be low in a mainly mild winter);
 - b) the EU dynamism in the use of all possible extra-EU export opportunities.
6. Weather factors are also to be observed carefully because of their influential weight in quality (sugar content, taste, colour...) and especially as a major element that will determine whether or not the crop can be stored for a long time in excellent quality conditions.

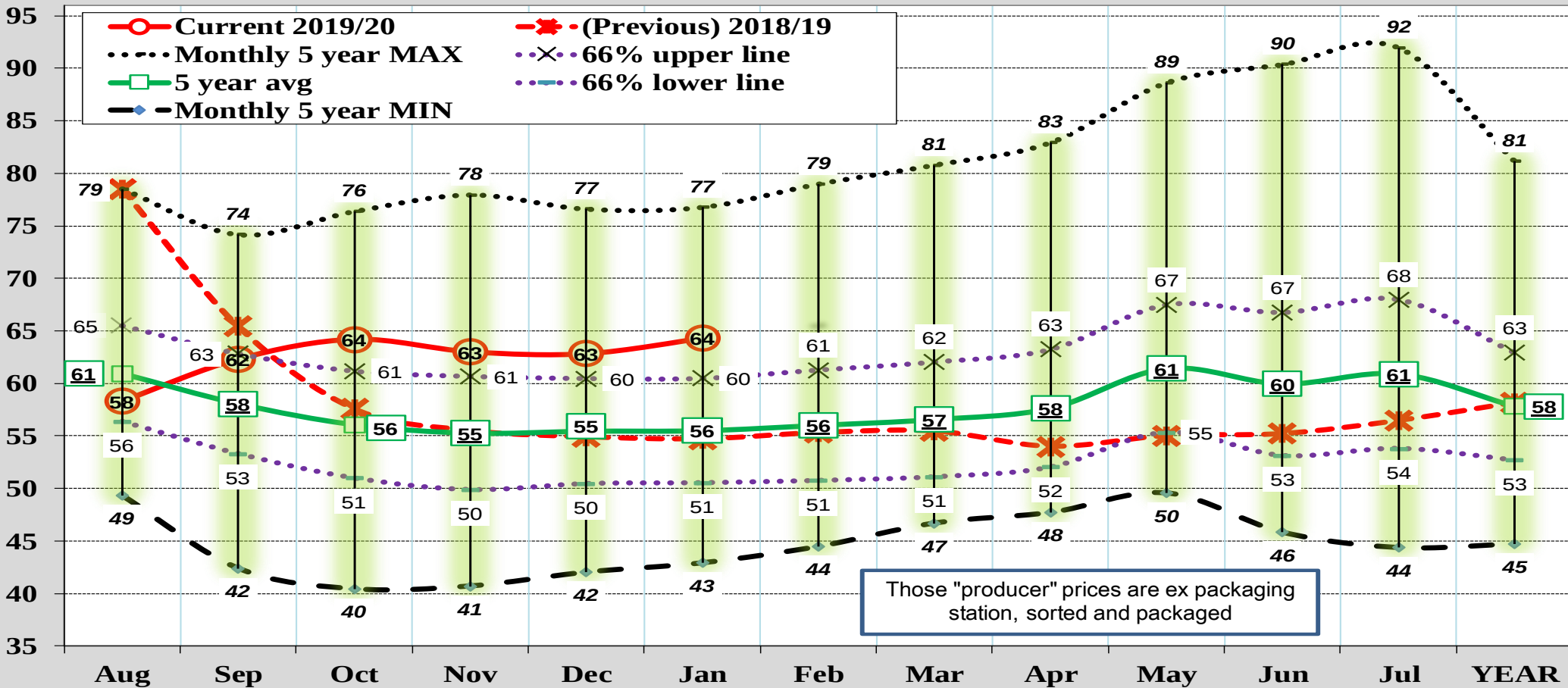

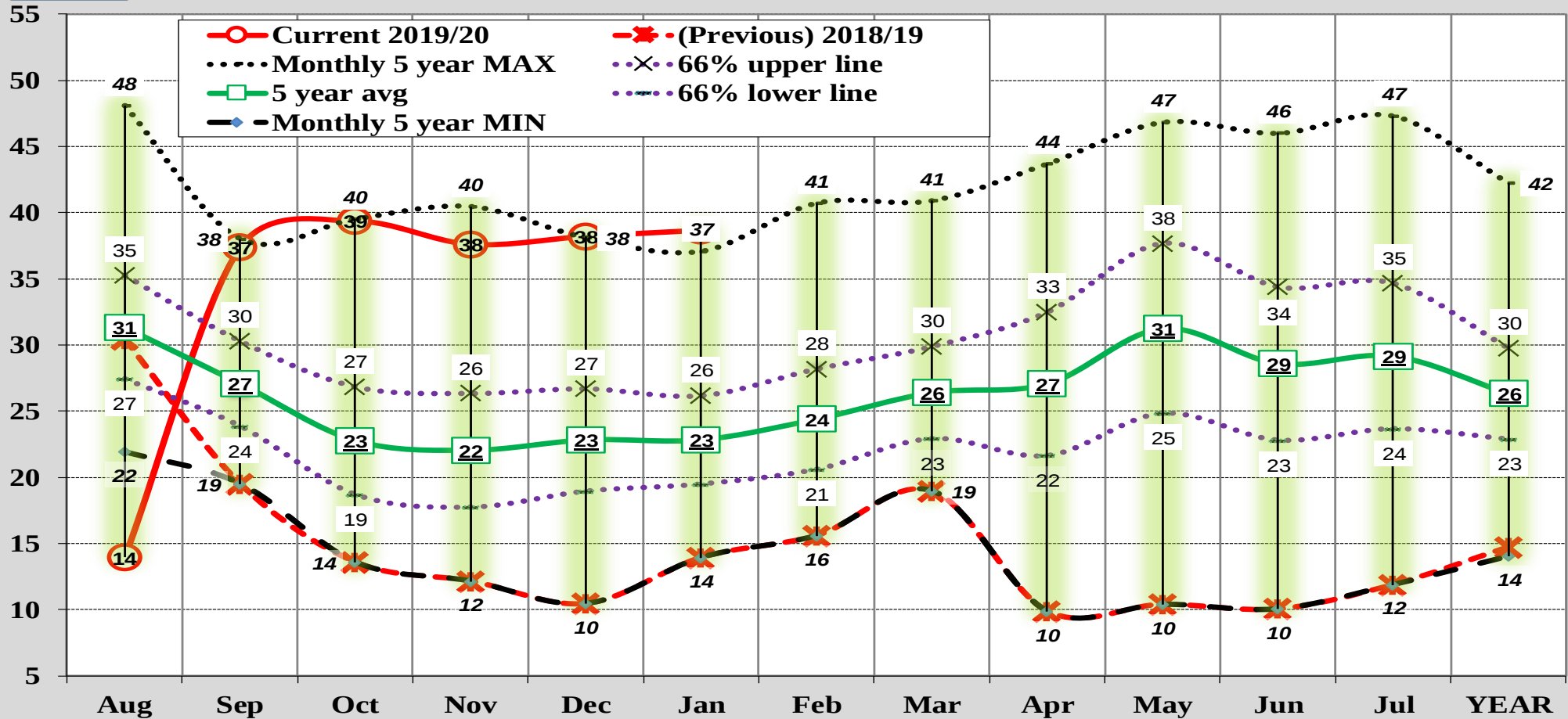

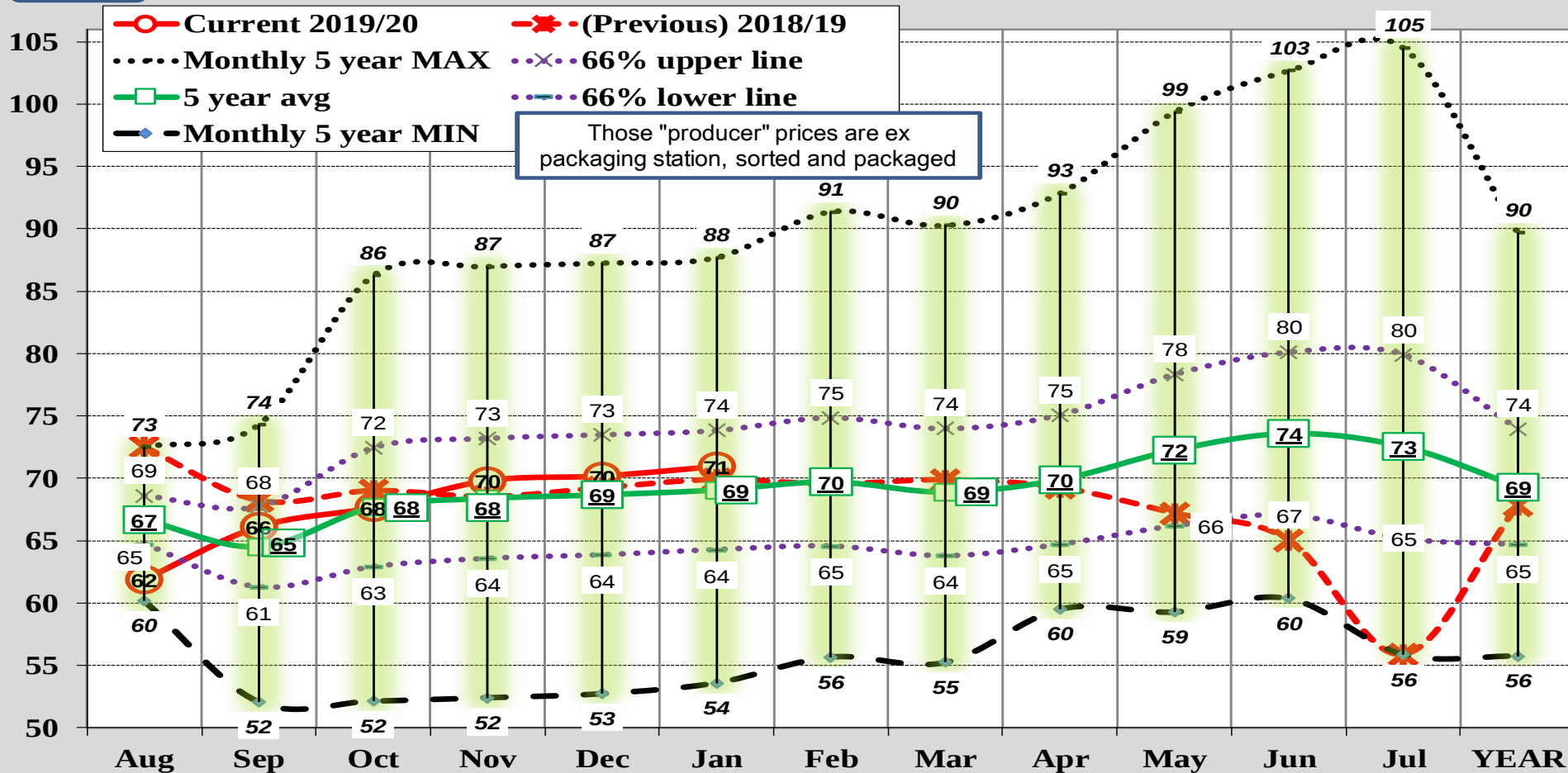

Apple prices in Poland (€/100kg=Euro cents/kg)



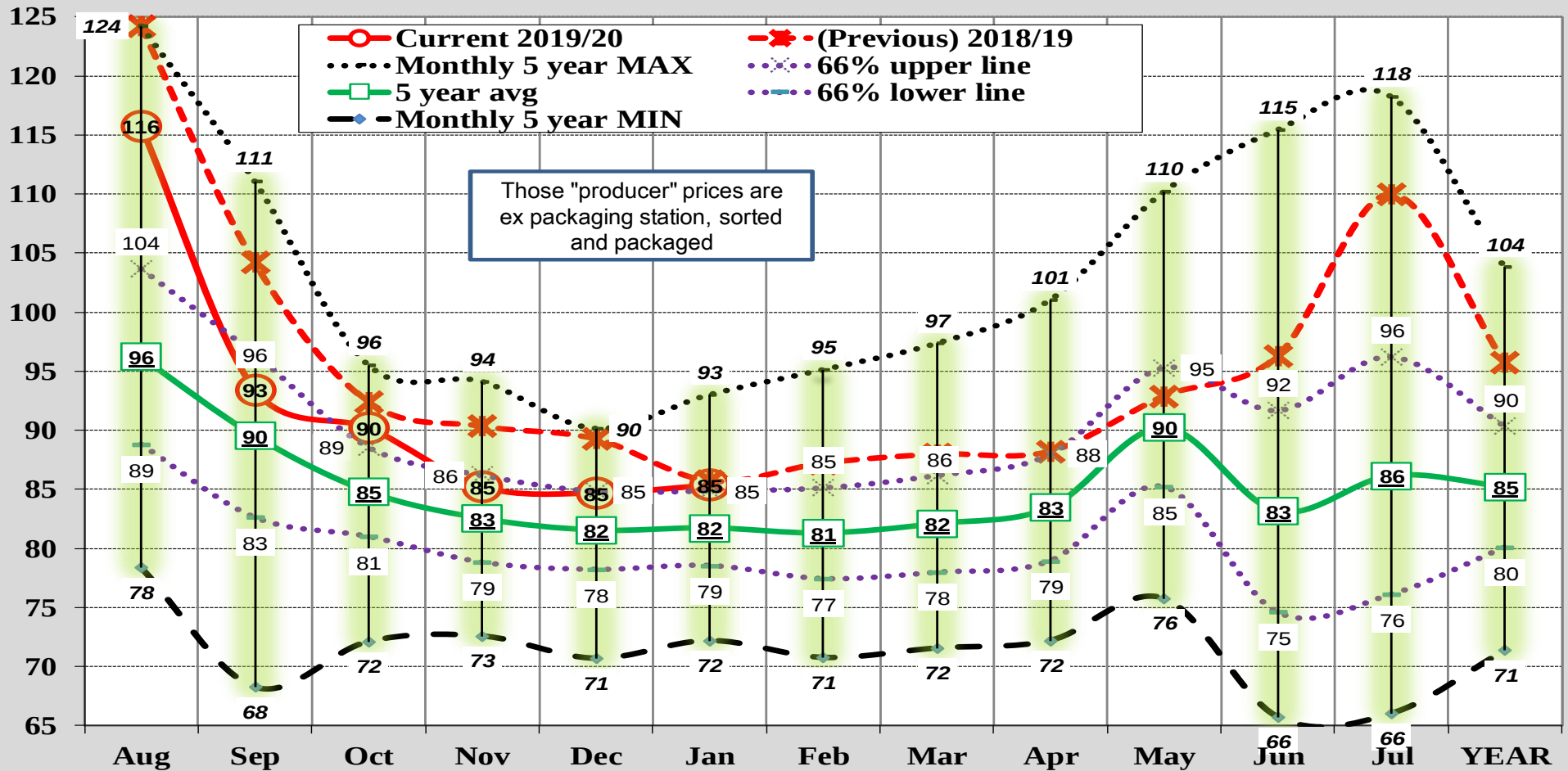

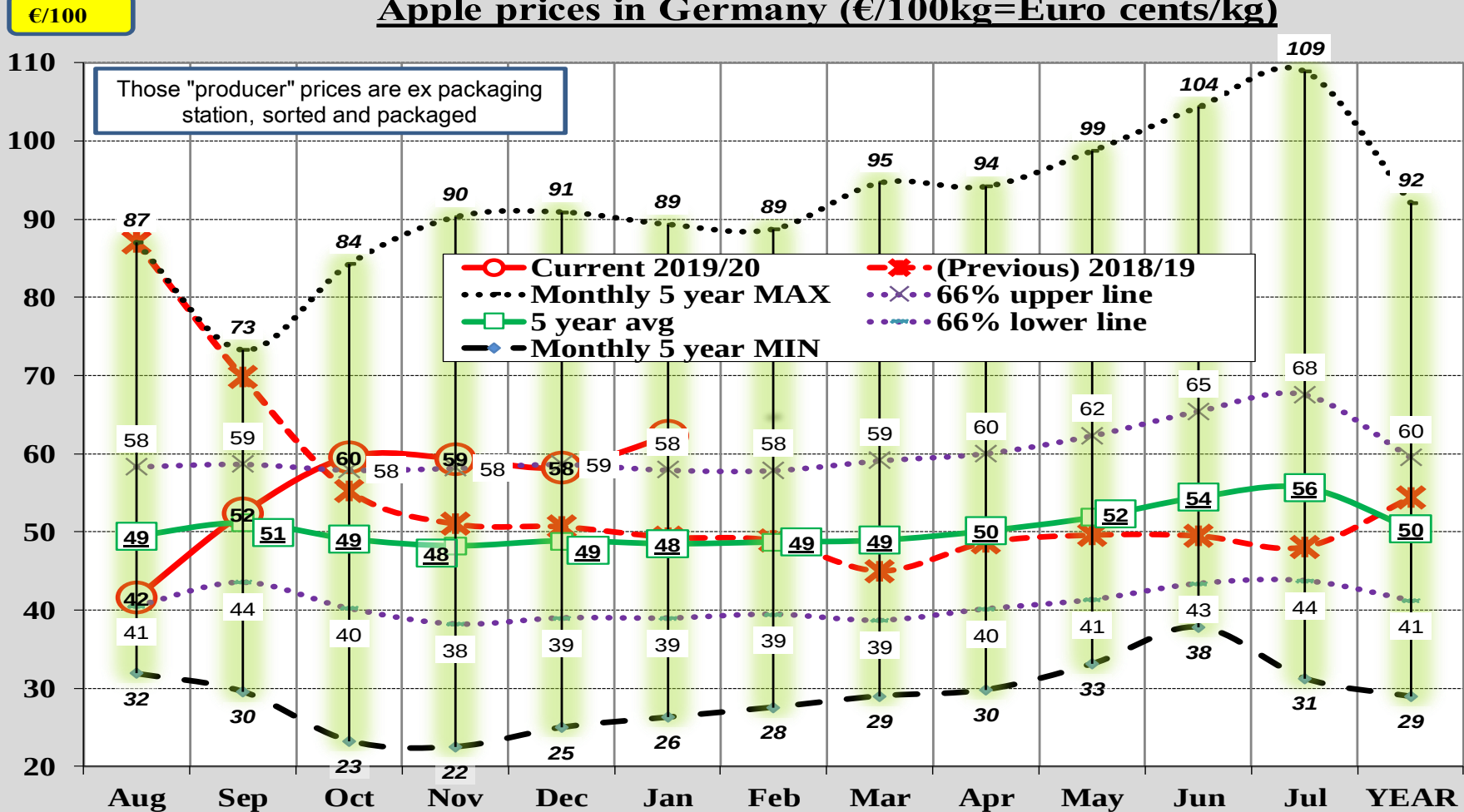

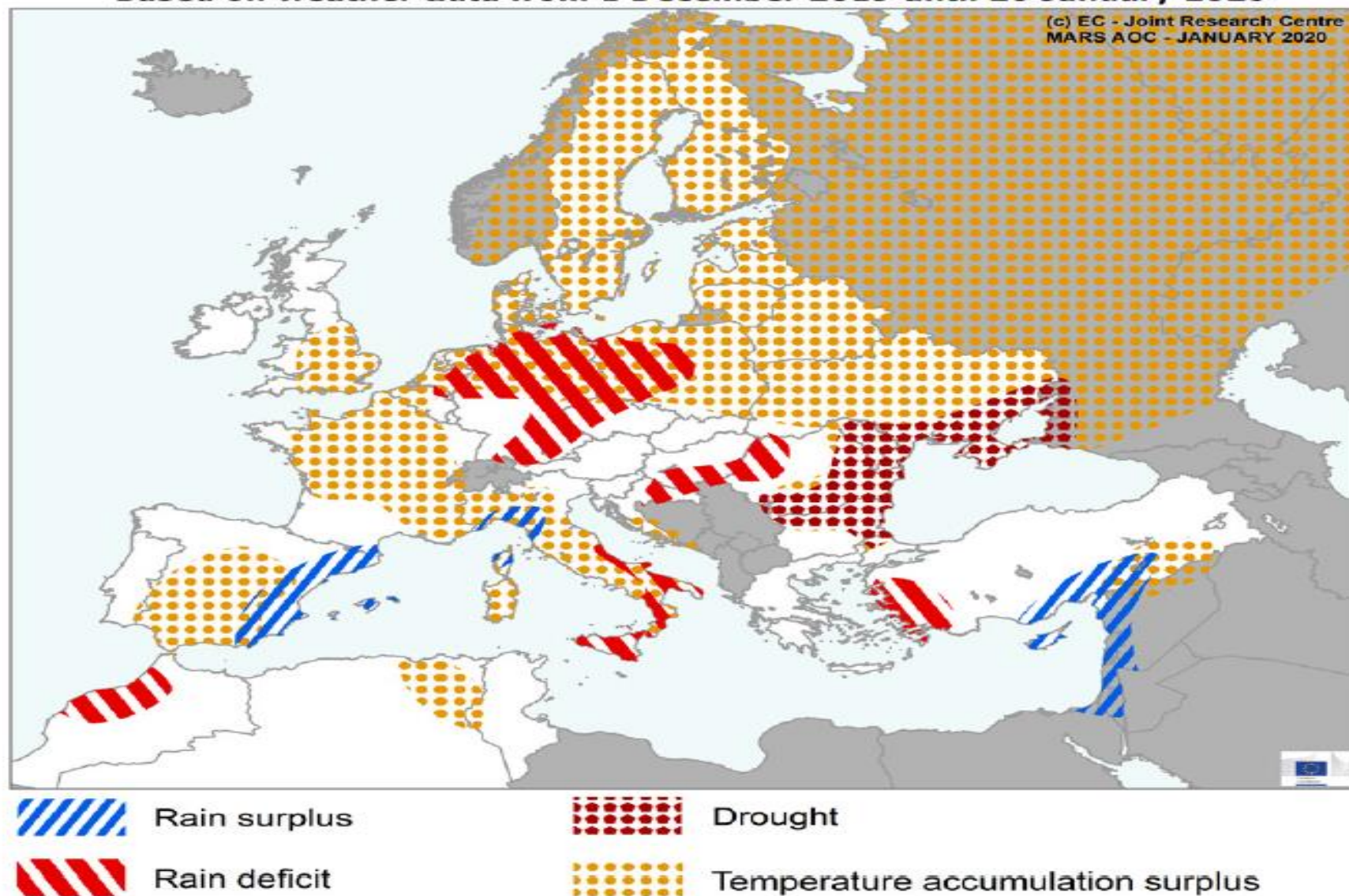

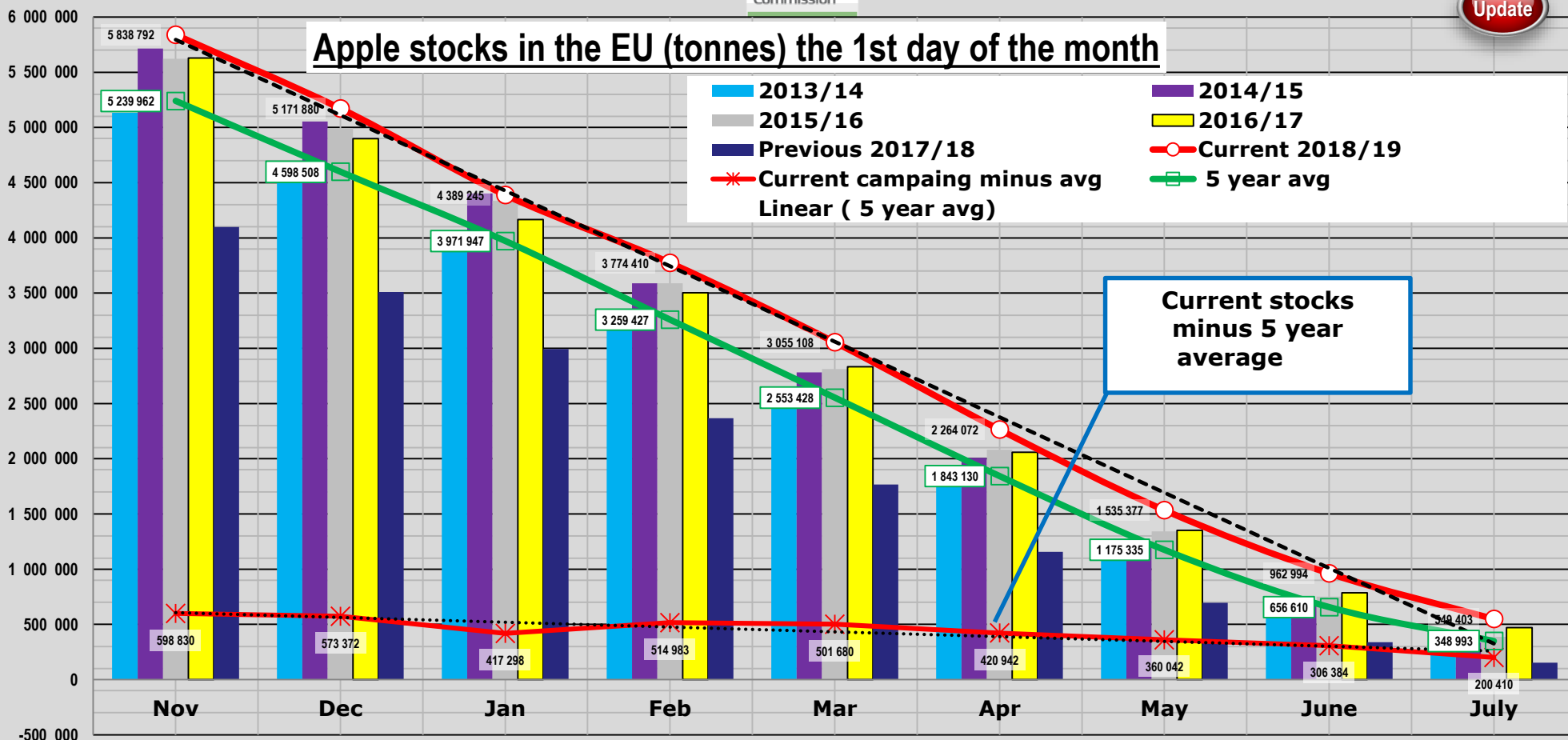
AREAS OF CONCERN - EXTREME WEATHER EVENTS

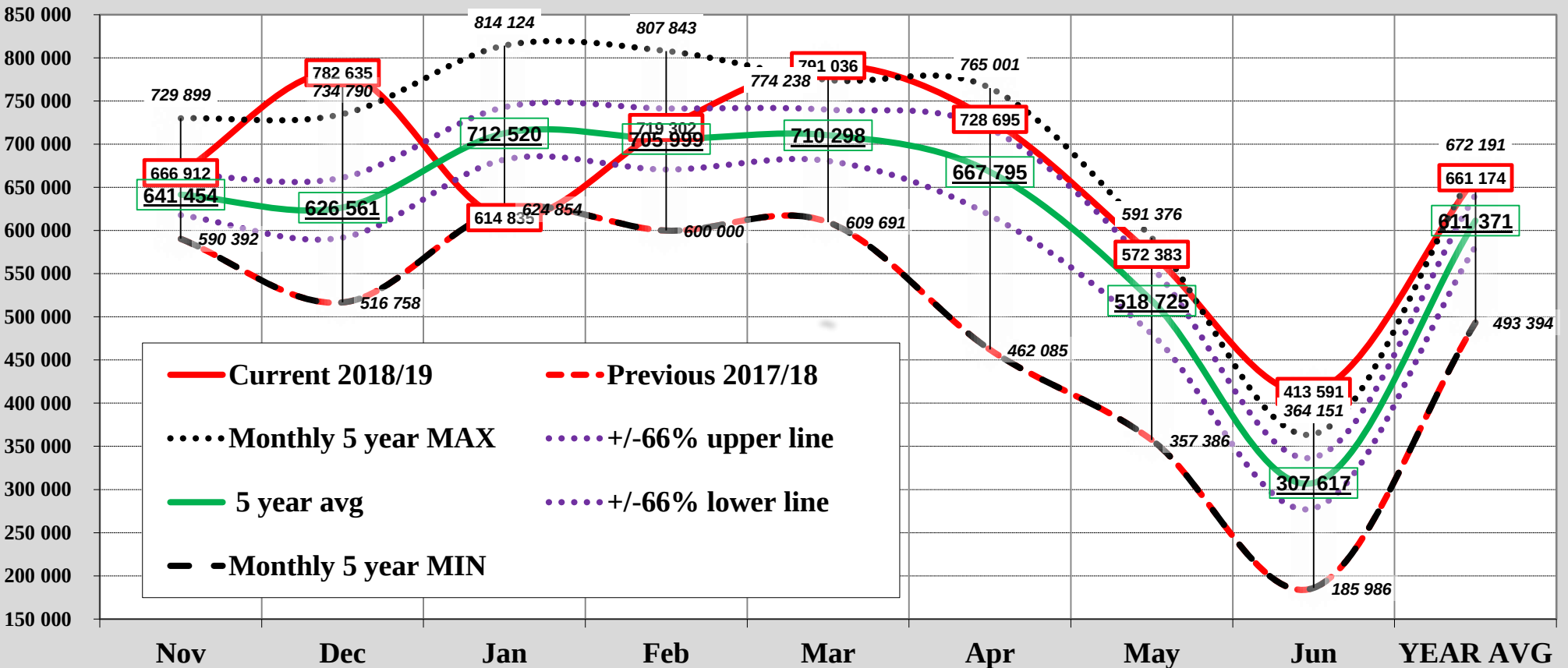
Apple stocks in the EU (tonnes) the 1st day of the month

Apples - Monthly unstocking rates in the EU - tonnes



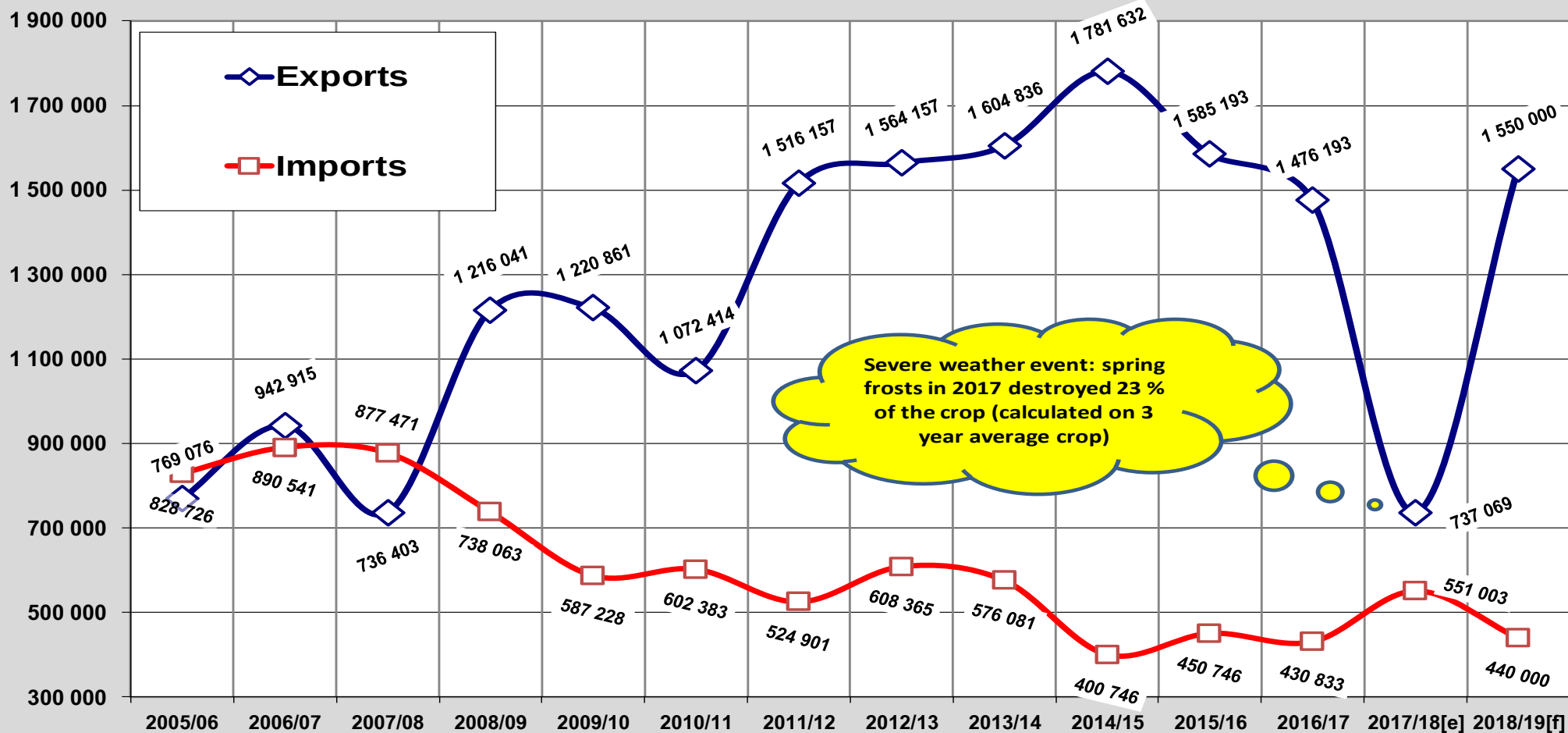

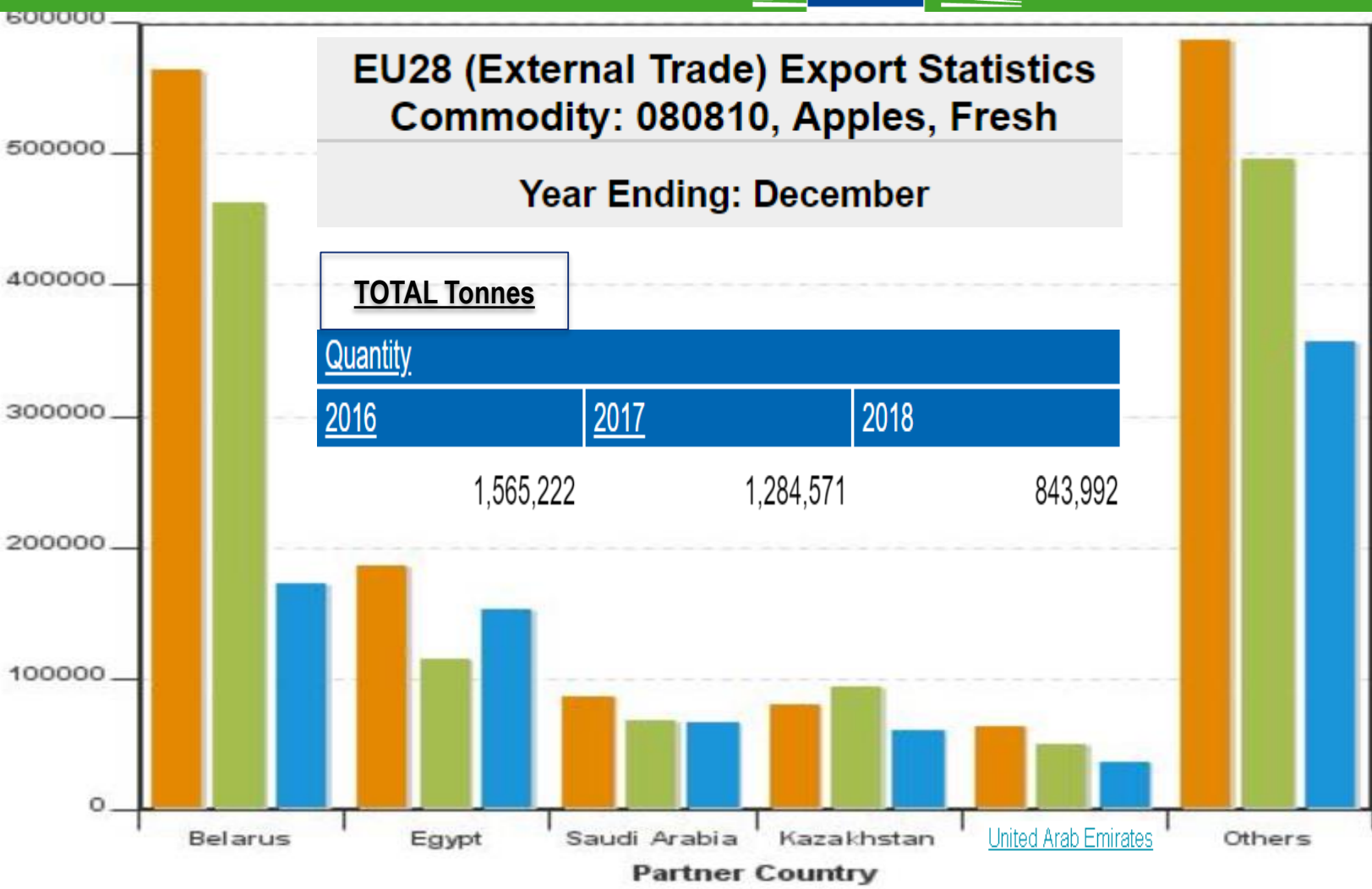

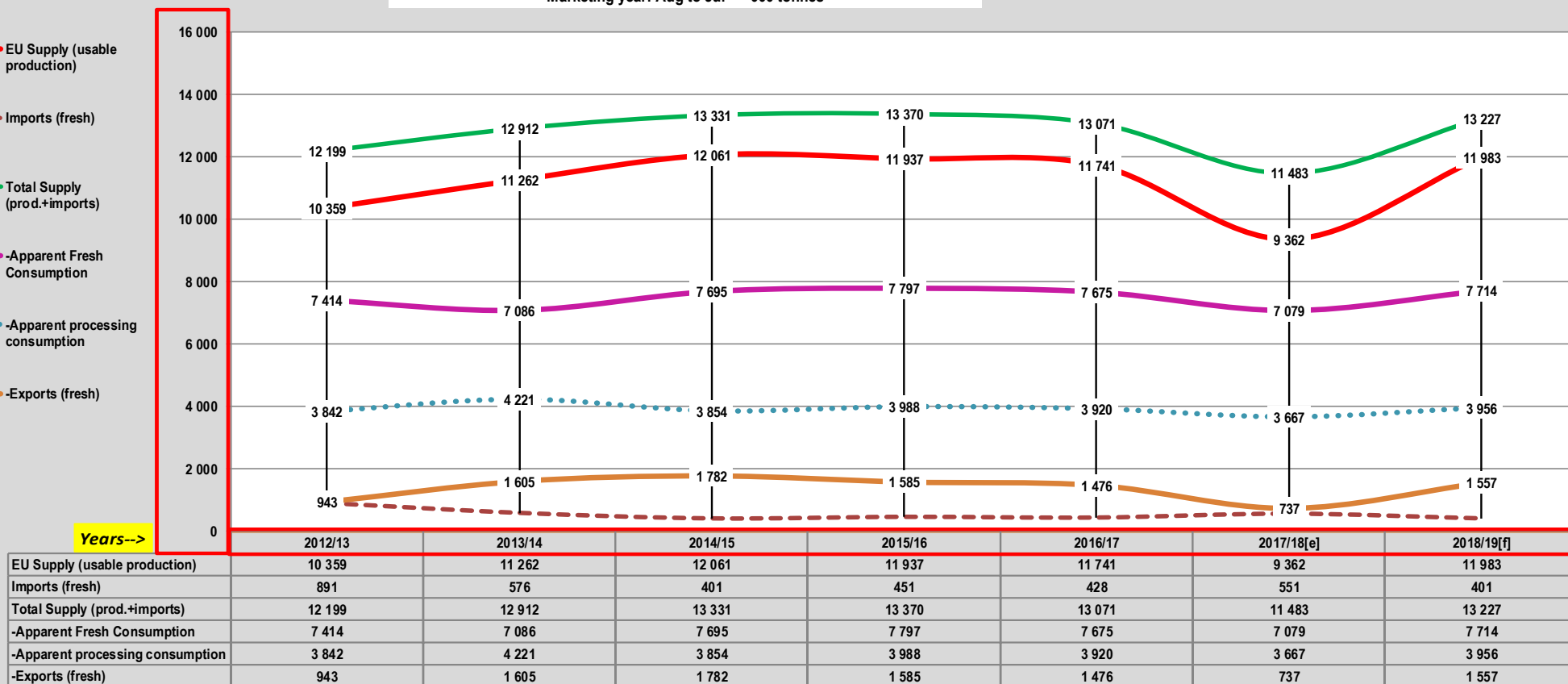

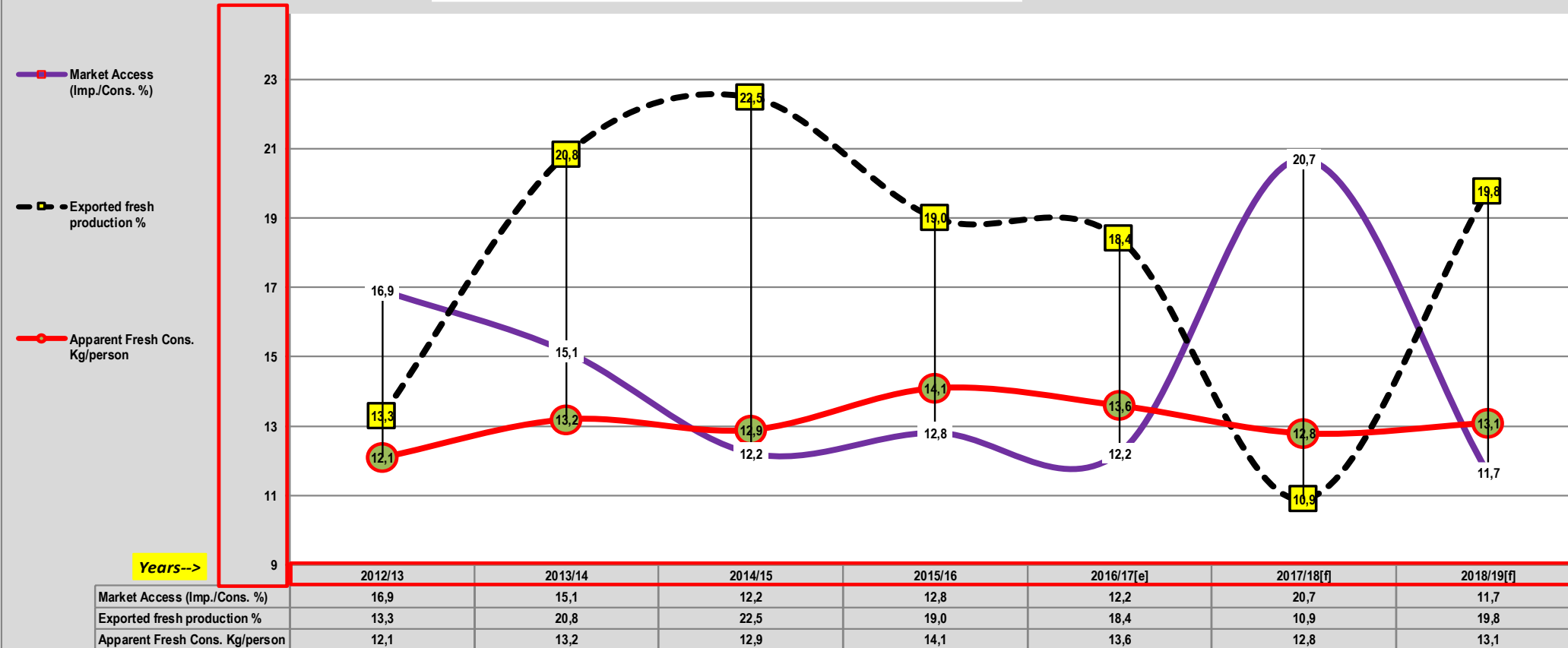

Marketing year: Aug to Jul - Units: % and kg per person (consumption)

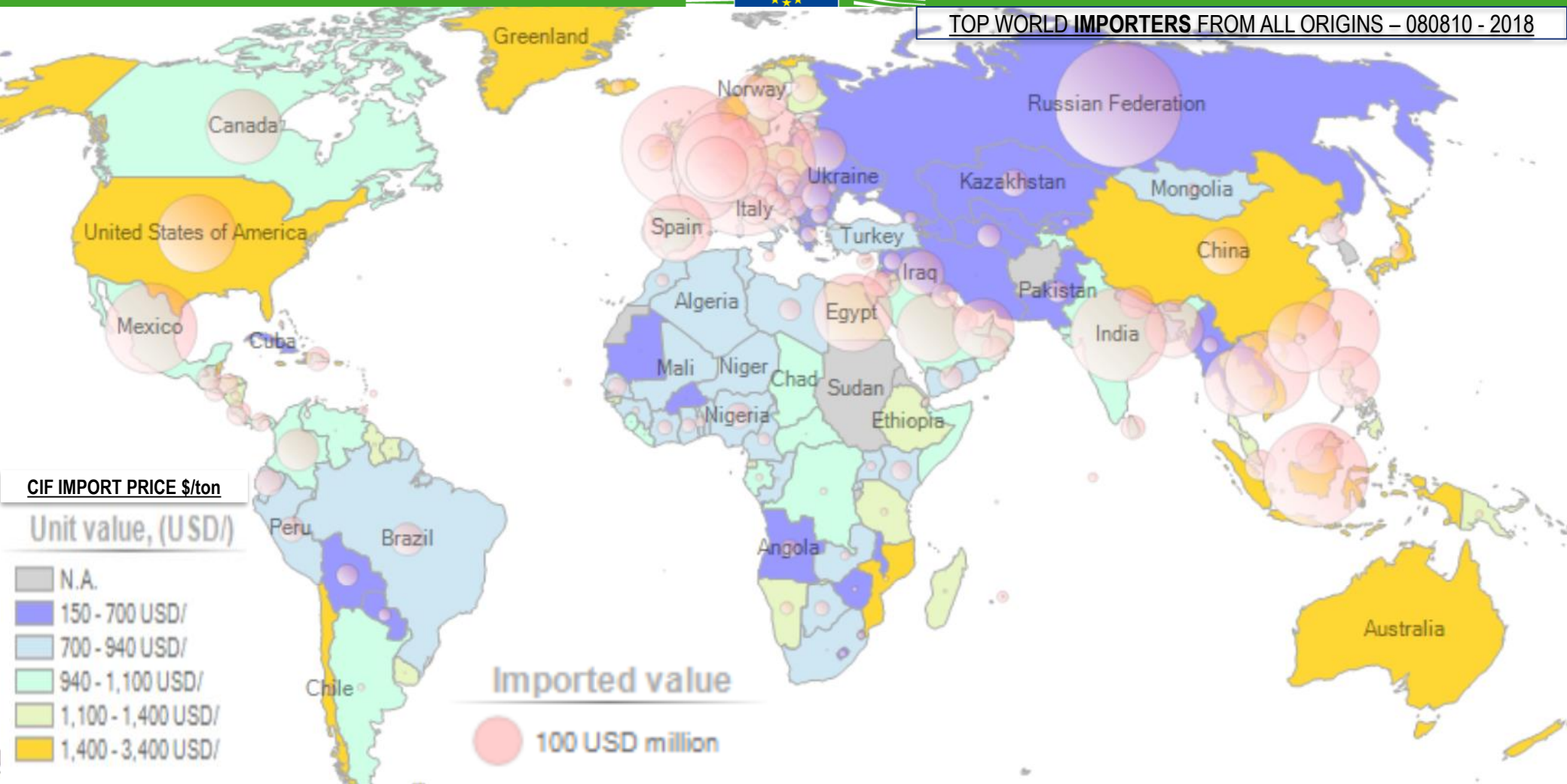

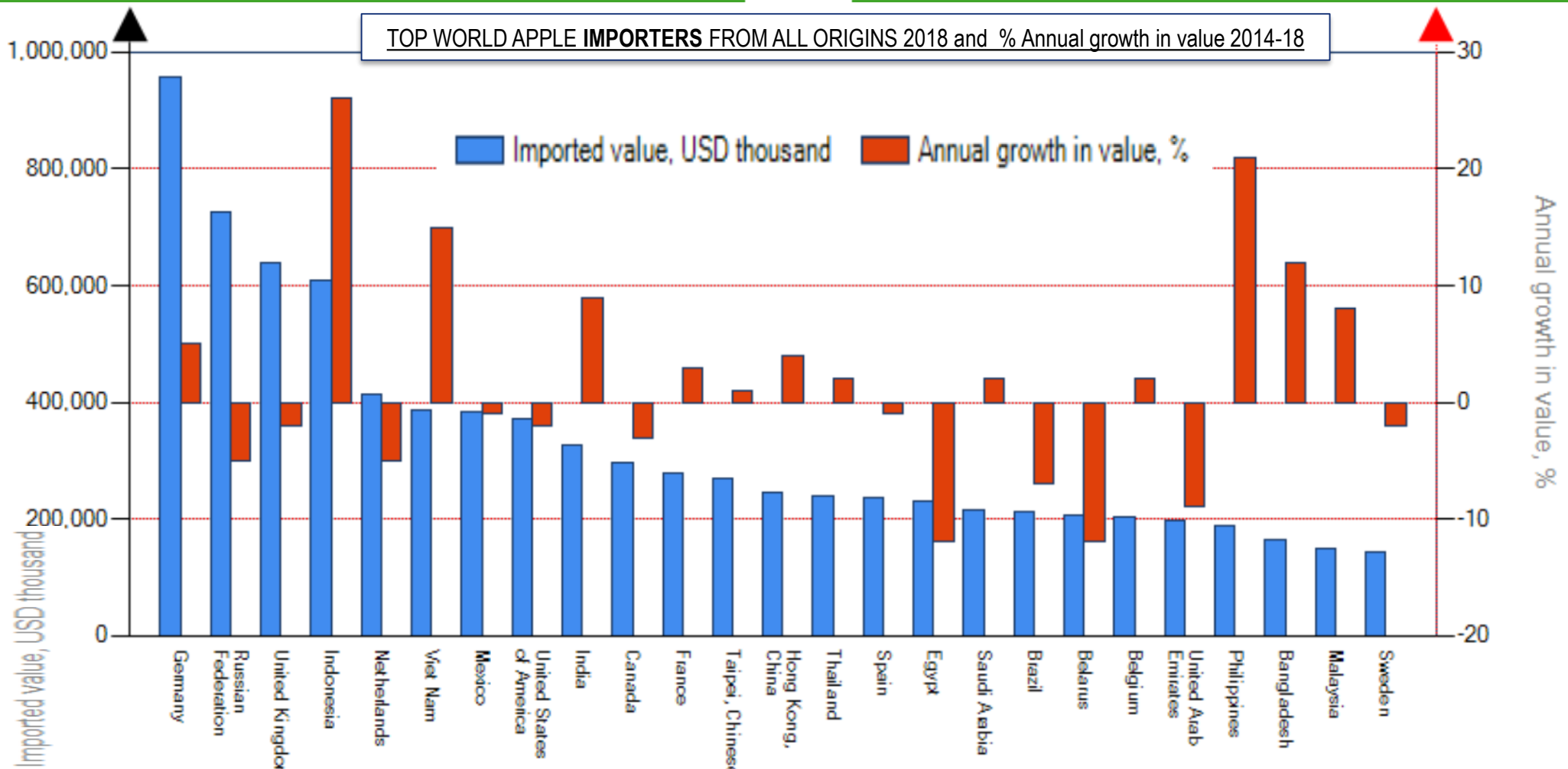

TOP WORLD IMPORTERS FROM ALL ORIGINS – 080810 - 2018



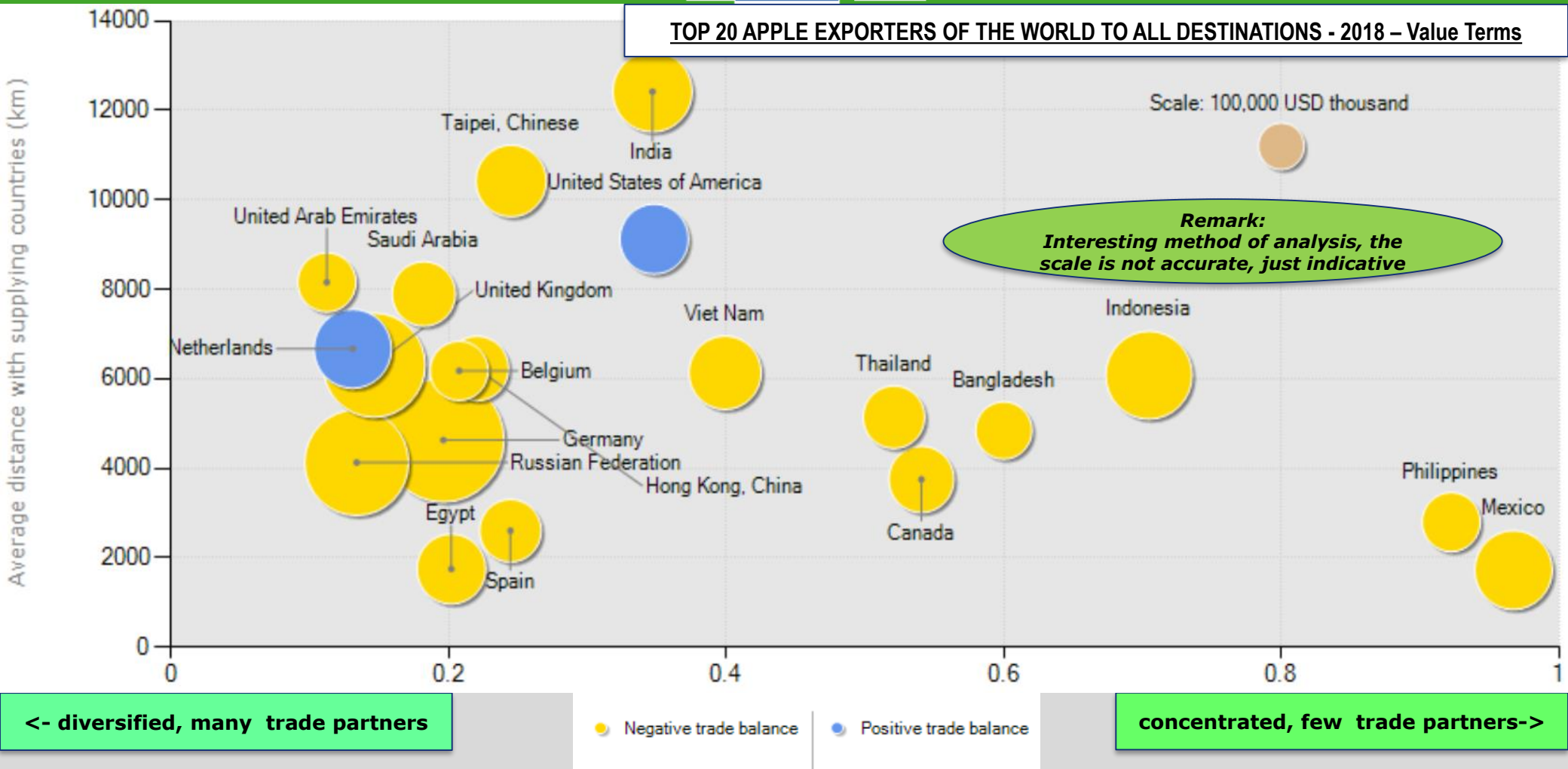

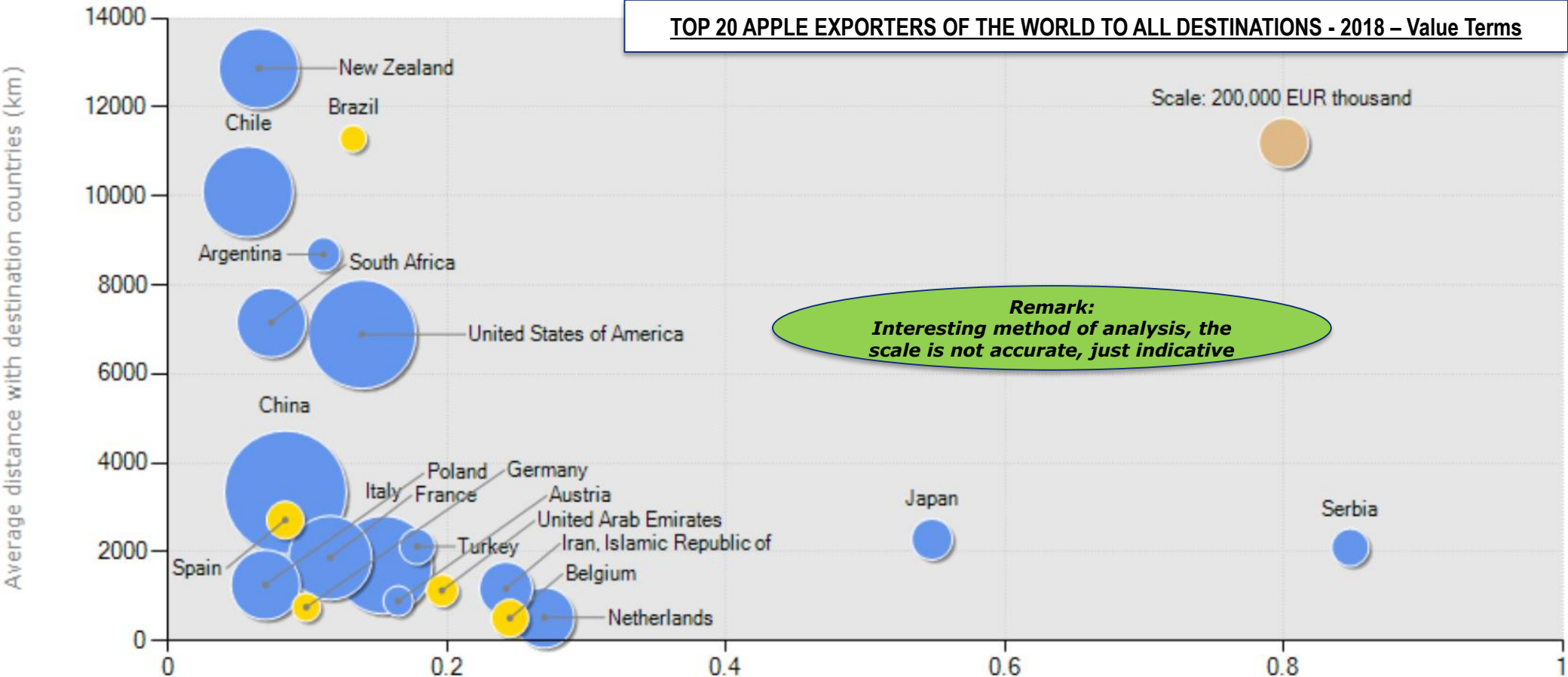

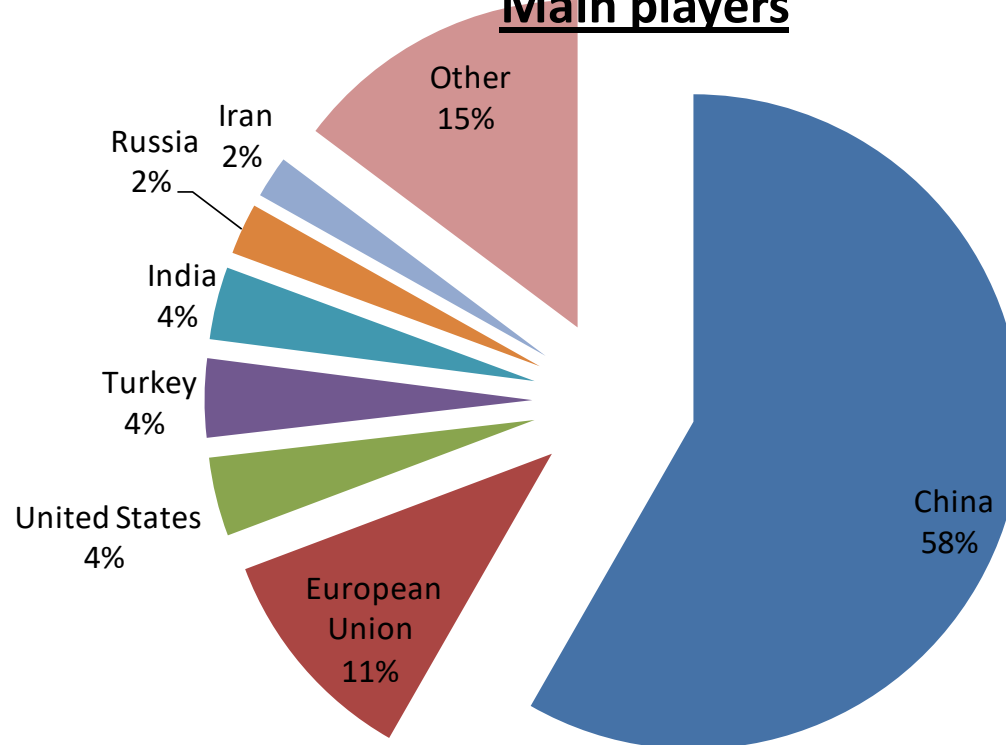
