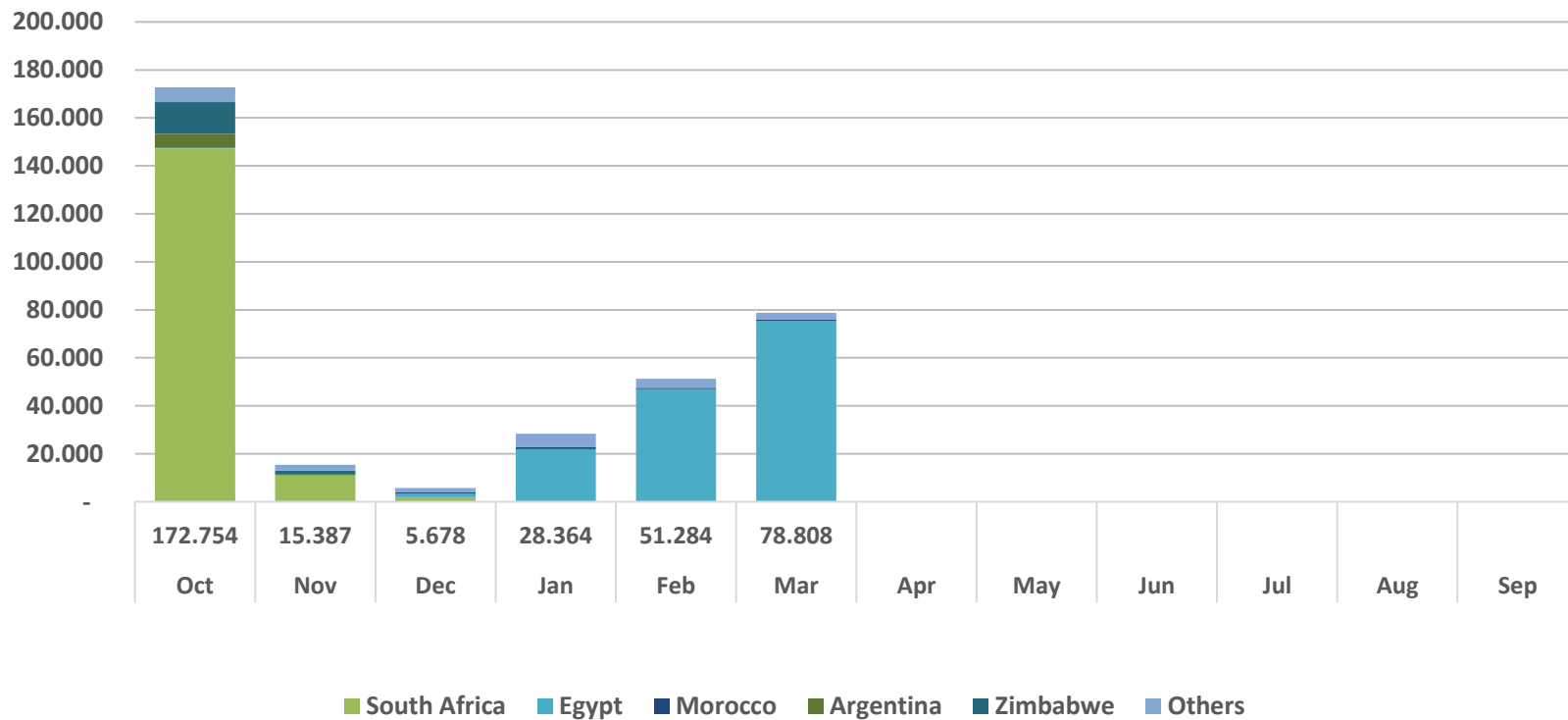


2022/23 EU monthly orange imports [tonnes]

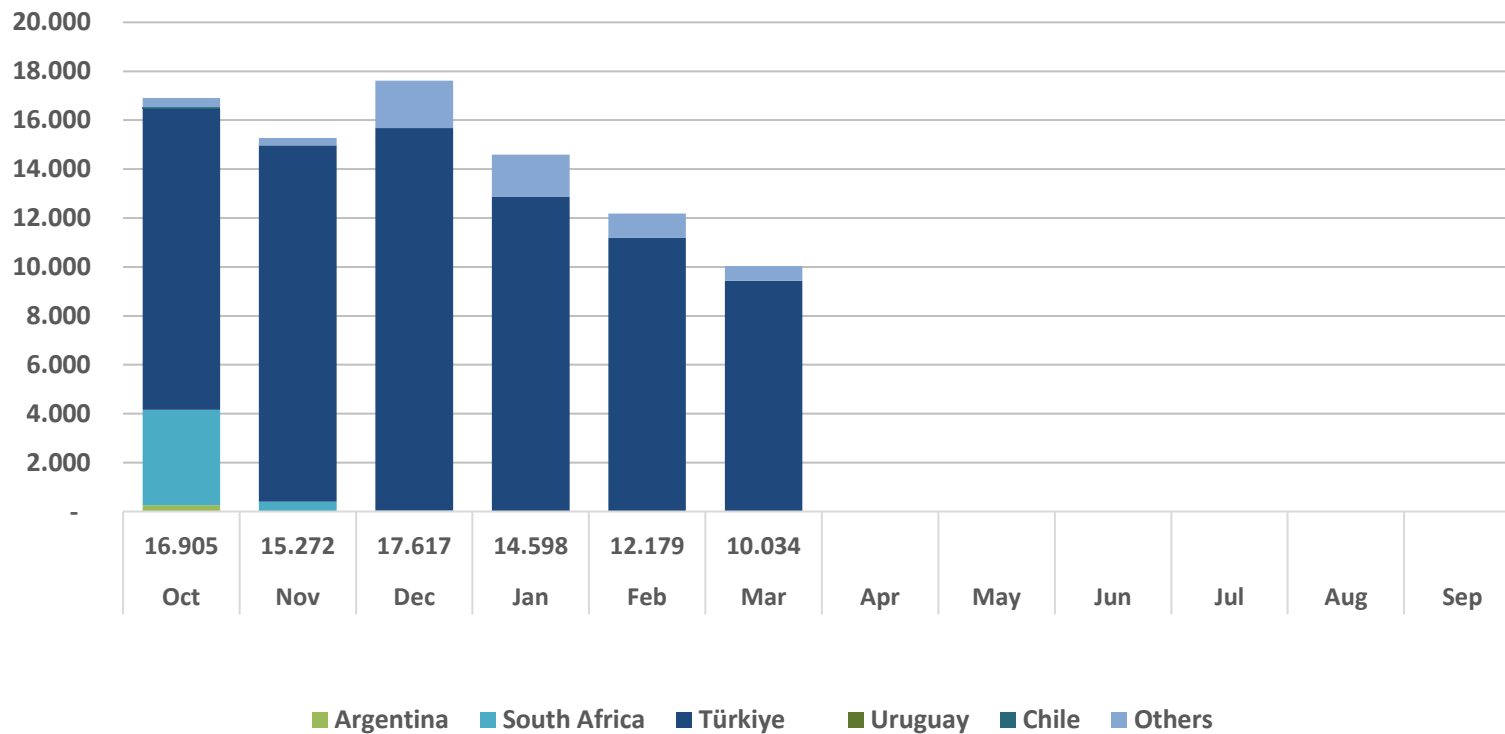

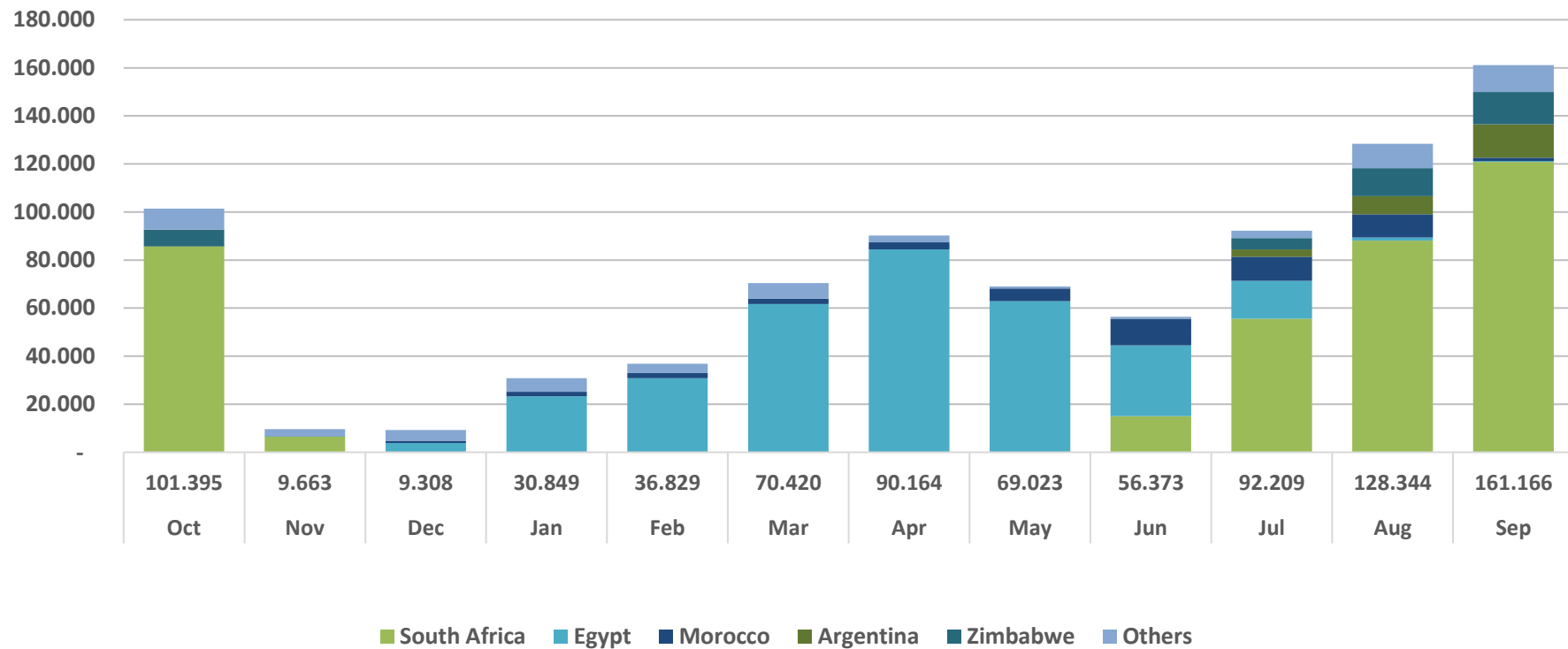
2021/22 EU monthly orange imports [tonnes]

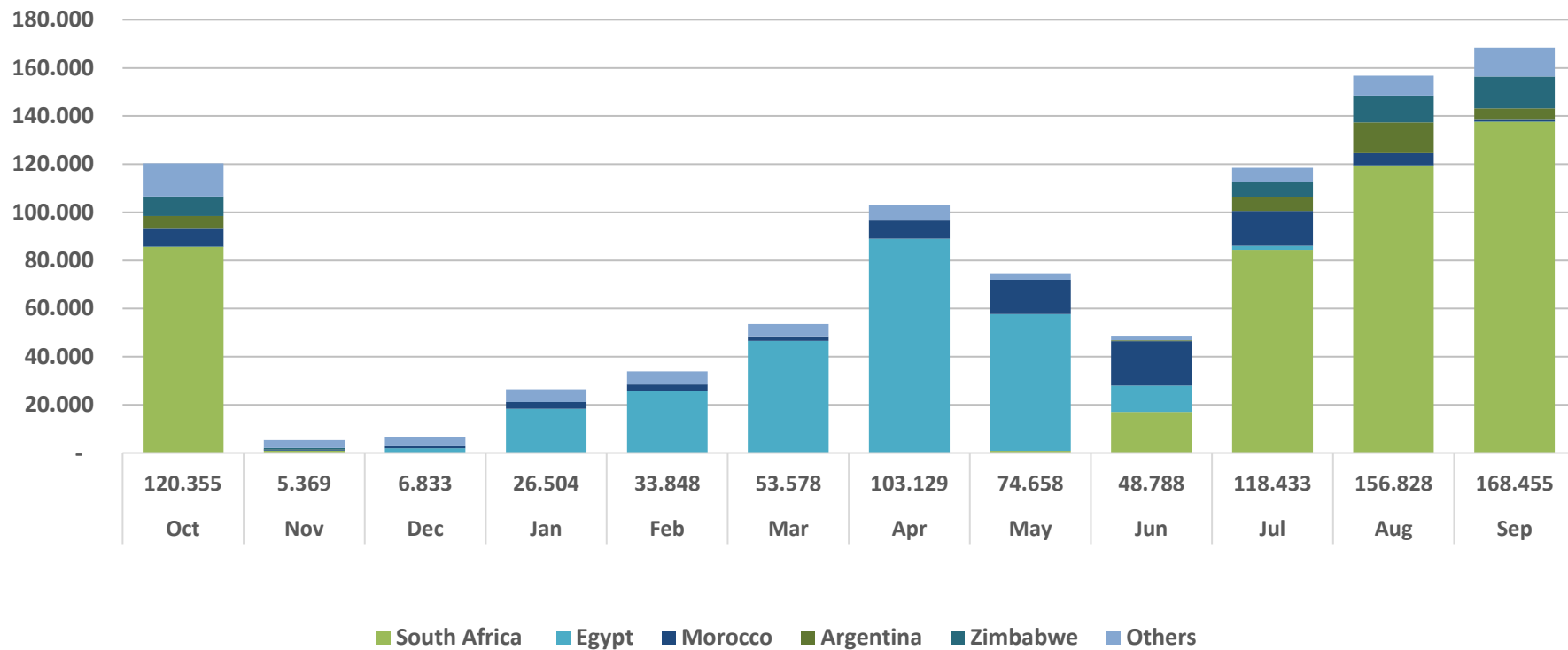
